ARC - BUSINESS DEVELOPMENT REVOLVING LOAN GRANT

RLFs are designed to fill gaps in existing local financial markets and to provide or attract capital which otherwise would not be available for economic development. Create and retain jobs. Eligible applicants for ARC RLF grant assistance include States, Local Development Districts, and other non-profit multicounty organizations. Machinery, equipment and other fixed asset acquisition, new construction, alteration, modification, repair and renovation of existing facilities, demolition and site preparation, land acquisition, working capital, refinancing existing debt. As part of the grant agreement, ARC requires that RLF projects be administered in accordance with a revolving loan fund plan developed by the grant applicant and approve by the Commission.
